

Privacy policy for attending online training courses and newsletter subscription - Art. 13 of Regulation (EU) 2016/679

Privacy Policy on the processing of personal data on the website: This Privacy Policy is intended to provide information about the processing, the purposes, the methods and, more generally, about the management of the personal data collected through the website "Hypertraining" (https://training.hypercharger.it/). This privacy policy applies only to this website, thereby excluding additional pages that can be accessed via link. Therefore, and in accordance with Article 13 of EU Regulation 2016/679, we inform you of the following:

Our company guarantees, within the framework of the legal requirements, that the processing of personal data is carried out according to the fundamental rights and freedoms as well as in compliance with the dignity of the data subject, particularly regarding confidentiality, personal identity and the right of protection of personal data.

DATA PROCESSING FOR ONLINE TRAINING COURSES

Purpose of data processing: The data processing is used to book selected online training courses as a company via our Hypertraining website, as well as to register the technicians/employees of the company to be trained, to participate in the training course, to receive the training certificate if the training course is passed and to handle the payment process. Pursuant to Art. 6(1)(b) and (c) of the GDPR, this data is collected in order to conclude the contract for participation in the training (contractual purposes) and to issue the corresponding invoice, if the training is charged. Any omission to provide this data makes it impossible to book or participate at the trainings.

Personal data processed: The data processed through the website are simple personal data (for example, but not exclusively: name and surname of contact person of the company, that books the training, e-mail addresses, anagraphic data, etc.) and, in general, all the data necessary to process required for elaboration and performance of the training as well as for payment purposes.

Type of data processing: Data processing may be carried out with or without the aid of electronic means and includes all the operations provided for in Article 4, paragraph 2 of Regulation (EU) 2016/679 and necessary for the data processing in question.

In any case, the data processing will be carried out in compliance with all security measures that ensure their security and confidentiality. The personal data will only be processed within the meaning of this Privacy Policy by employees and collaborators of the company who have been explicitly appointed as data protection processors.

The employees have been adequately trained in this regard and work under the direct supervision and responsibility of the Data Protection Processing.

Duration of processing: The personal data processed will be stored for as long as necessary (i) for the purposes pursued or (ii) to protect the legitimate interests of Alpitronic. The data will be stored for 10 years. This is the period during which customers may assert claims for damages for product liability. Alpitronic Srl requires this data to clearly identify the training participants in the event of a claim. The data necessary for accounting purposes are stored for the period of 10 years provided by law.

DATA PROCESSING FOR NEWSLETTER-SUBSCRIPTION

Purpose of data processing: Through the data processing, the data subject receives the Hypertraining newsletter via e-mail after his or her consent. According to Art. 6, paragraph 1, letter a) GPPR, the consent of the data subject is mandatory. The consent is given via a corresponding opt-in button.

Personal data processed: The data processed through the website are simple personal data (e-mail addresses).

Type of data processing: Data processing may be carried out with or without the aid of electronic means and includes all the operations provided for in Article 4, paragraph 2 of Regulation (EU) 2016/679 and necessary for the data processing in question. In any case, the data processing will be carried out in compliance with all security measures that ensure their security and confidentiality. The personal data will only be processed within the meaning of this Privacy Policy by employees and collaborators of the company who have been explicitly appointed as data protection processors.

The employees have been adequately trained in this regard and work under the direct supervision and responsibility of the Data Protection Processing.

Duration of processing: The processed personal data will be stored until the data subject revokes his or her consent. The revocation can be made in the newsletter using the "unsubscribe newsletter" function. Furthermore, the revocation can be made by communicating the intent of revocation directly to the data controller (Alpitronic). The contact details are listed below.



GENERAL PROVISIONS FOR DATA PROCESSING

Dissemination: The personal data processed will not be spread.

Automated decision-making: The processing of the data is not based on automated decision-making.

Rights of the data subject: Regulation (EU) 2016/679 gives data subjects the opportunity to execute certain rights according to Articles 15-22. The data subject has the right to know what personal data the data processor holds from the respective person, to obtain information about whether data on the respective person exists and to be given an intelligible form more detailed information about the data, origin and the reason and purpose of its processing, as well as information about the superordinate of the processing people and categories of people, to whom this data is transmitted. The data subject has the right to confirm and control, correct and supplement respective data, to request that the data be deleted, blocked and converted into anonymous data if the processing violates the legal provisions. The data subject has the right, to oppose with justified reasoning, to the processing of respective data, in whole or in part, as well as to request its deletion, blocking or transformation into anonymous data. If the data subject does not receive a response to a request within 30 days of receipt – this period may be extended by a further 60 days if this is necessary due to the complexity or the high number of requests – the data subject may lodge a complaint with the Data Protection Authority or submit an appeal to the court.
